EVERGREEN ASSESSMENT TIPS

Although assessment is a continuous process, the academic year aligns neatly with the natural starting and stopping points of the cycle. Analysis, the penultimate step in annual assessment, determines the direction of not only the final step, but the assessment cycle to follow. Consider the following questions as
